I. Introduction

The African Development Bank (AfDB) recognizes the pivotal role of continuous learning and adaptive engagement in achieving sustainable development in Africa. In line with this commitment, the Quality Assurance and Learning Division (SNDR.3) is organizing two forthcoming events focused on the theme of learning loops. A learning loop is a systematic process of gathering feedback, reflecting on outcomes, adjusting, and then implementing those adjustments to improve performance or outcomes over time.

These events aim to harness the power of iterative learning and feedback mechanisms to drive operational excellence, foster innovation, and maximize development effectiveness of Bank operations in its Regional Member Countries. The two events will comprise of:

- Event 1: Learning Loops Training Masterclass Workshop
- Event 2: High-level Knowledge Event

This purpose this concept note is to serve as a planning document for the successful organization of the above events.

II. Background

Improved learning is critical for better long-term development outcomes and more sustainable results. At the AfDB, efforts have been made to promote learning particularly through the documentation of lessons learned in Country Portfolio Performance Reviews, Project Completion Reports for sovereign operations and Extended Supervision Reports in the case of non-sovereign operations. In addition, learning events and materials have been developed in some areas including through the Quality Matters initiative and capitalization workshops organized by IDEV. However, there is scope to go further if the Bank is to become a learning organization, especially with respect to the application of lessons learned to new operations.

In addition, learning considerations are further overlooked because of a bias towards performance ratings and accountability requirements. Previous evaluations by IDEV and other self-evaluations such as those conducted by MOPAN have underscored this concern for both sovereign and non-sovereign operations. The Bank's Ten-Year Strategy (2024-2033) amongst others, also emphasizes the need of building a culture of learning by incorporating learning into its strategic planning and operations.

In this context, SNDR.3 recruited Dr. Moses Adoko, Chief Knowledge Officer at NASA Goddard Space Flight Center and a renowned global expert in the field of learning loops to carry out a (i) diagnostic assessment of the Bank's learning architecture, processes and tools, and (ii) propose a framework and action plan anchored on international best practice to strengthen and improve the use of lessons learned extracted from self-evaluations and independent evaluations, tightening the feedback loops between Bank knowledge products and operations and ultimately improve the Bank's effectiveness and efficiency. As his diagnostic work concludes, he will visit Abidjan to share both his findings and his knowledge of global good practices on learning systems and learning organizations.

III. Expected Outcomes

The expected outcomes from the learning events include:

- Dissemination of the Findings of the Consultant's Diagnostic Report: Share the key findings for the assessment of the Bank and the proposals to strengthen accountability and lessons learning in the AfDB. This work will feed into the Quality, Results and Learning Action Plan (2025 -2030) of the Bank.
- Increased Understanding of Learning Loops in AfDB: Bank staff/participants should gain a clear understanding of what learning loops are, how they function, and their importance in driving continuous improvement and innovation within organizations such as the AfDB.
- Fostering a Culture of Learning and Adaptation: Participants be exposed to strategies for deploying the practice of continuous learning, experimentation, and adaptation within their work in the Bank, where feedback is valued, and change is embraced.
- Increased Operational Efficiency and Effectiveness: Participants should be able to contribute to the Bank's implementation of learning loops with the goal to improve operational efficiency, effectiveness, and overall performance, leading to tangible business results.

Guidance Note for Panel Discussion on Promoting Lesson Learning in the Bank

Friday, 14th June 2024

Panel Discussion

The African Development Bank (AfDB) recognizes the pivotal role of continuous learning and adaptive engagement in achieving sustainable development in Africa. In line with this commitment, the Quality Assurance and Learning Division (SNDR.3) is organizing a high-level learning knowledge event titled "Are We Really Learning?" This event aims to harness the power of iterative learning and feedback mechanisms to drive operational excellence, foster innovation, and maximize development effectiveness of Bank operations in its Regional Member Countries. Based on their professional background and experience, the panelists are requested to share their views on lessons learning practices in Bank Operations.

Please review the concept note for more information regarding the theme, including the event's concept note and program.

The chair will introduce the panelists and ask each one to react to the keynote and to share his/her own perspectives on the theme in approx. 3-4 minutes. Thereafter, the moderator/chair will field questions to panelists, yourself included, drawing on the guiding questions below as well as follow-up questions based on the individual and collective responses of the session panelists. After a round of questions from the moderator, the discussion will be opened-up to the wider audience. The chair or moderator will drive the question-and-answer time during which the audience will engage in a conversation with the panelists.

We recommend that panelists focus their initial intervention on no more than 3 key points in approx. 3-5 minutes. The discussion questions that will be asked of you by the moderator may include:

- To what extent is the Bank successfully capturing lessons from operations?
- How effective is the Bank in applying lessons from one operation to the next, or from operations to policies and strategies? Any specific examples from your own experience in the Bank?
- What are some of the constraints and opportunities for promoting operations lessons learning in the AfDB context?
- Do accountability and learning mutually support each other or can one overshadow the other?
- How can the Bank institutionalise learning or become a learning organisation?
